RESOLUTION NO. 1487

REMOVING BOHOL AS A TESTING CENTER FOR THE MARCH AND JUNE 2022 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1439 (s. 2021) scheduling the licensure examinations for calendar year 2022 wherein the Licensure Examination for Professional Teachers (LEPT) is set on March 27, 2022 and June 26, 2022 in the National Capital Region (NCR), Bacolod, Baguio, **Bohol**, Butuan, Cagayan De Oro, Catanduanes, Catarman, Cauayan, Cebu, Davao, Dumaguete, Iloilo, Kidapawan, Koronadal, Legazpi, Lucena, Pagadian, Pampanga, Rosales, Tacloban, Tuguegarao, Jolo (Sulu), Tawi-Tawi, and Zamboanga;

WHEREAS, Resolution No. 1483 (s. 2022) was issued designating Masbate and Mati as additional testing centers for the March 2022 LEPT;

WHEREAS, Resolution No. 1485 (s. 2022) was issued removing Tawi-Tawi as a testing center for the March 2022 LEPT and giving concerned examinees the option to transfer to other testing venues until March 19, 2022;

WHEREAS, with the accumulation of examinees due to the postponement of the LEPT in 2020, the Commission, through Resolution No. 1363 (s. 2021), decided to divide the number of examinees into four (4) batches in different testing centers to be able to accommodate all examinees during this pandemic;

WHEREAS, in a letter dated 18 March 2022, Director Narcival Randie Z. Taquiqui of PRC-Cebu requested the removal of Bohol as a testing center as there are no examinees left for the third (3^{rd}) and fourth (4^{th}) batches of the March 2022 and June 2022 LEPT registered therein;

WHEREAS, based on this representation of PRC-Cebu, the Professional Regulatory Board for Professional Teachers and the Licensure Office recommend to remove Bohol as one of the testing centers for the March and June 2022 LEPT;

WHEREFORE, in view of the foregoing, the Commission **RESOLVES**, as it hereby **RESOLVED**, to **REMOVE BOHOL** as a testing center for the March and June 2022 LEPT;

RESOLVED FURTHER, that the Licensure Examination for Professional Teachers shall proceed as scheduled in the NCR, Bacolod, Baguio, Butuan, Cagayan De Oro, Catanduanes, Catarman, Cauayan, Cebu, Davao, Dumaguete, Iloilo, Kidapawan, Koronadal, Legazpi, Lucena, Masbate, Mati, Pagadian, Pampanga, Rosales, Tacloban, Tuguegarao, Jolo (Sulu), and Zamboanga on March 27, 2022.
