## RESOLUTION NO. 1391

## CANCELLING THE AUGUST 2021 VETERINARIANS LICENSURE EXAMINATION IN PRC - CAGAYAN DE ORO

**WHEREAS**, Section 7 (d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and to determine and fix the places and dates of examinations;

**WHEREAS**, the Commission issued Resolution No. 1283 (s. 2020) scheduling the licensure examinations for calendar year 2021 wherein the Veterinarians Licensure Examinations (VLE) are scheduled on February 2, 3 & 4, 2021 and August 4, 5 & 6, 2021 to be held in NCR, Baguio, Cagayan de Oro, Cebu, Davao, and Tuguegarao;

WHEREAS, President Rodrigo R. Duterte approved the recommendation of the Inter-Agency Task Force (IATF) to retain the **Enhanced Community Quarantine (ECQ)** classification of Iloilo City and Iloilo Province in Region 6 and **Cagayan de Oro City** and Gingoog City in Region 10 starting **August 1 until August 7, 2021**<sup>1</sup>;

**WHEREAS**, on July 29, 2021, the Licensure Office received a letter from OIC - Director Maria Melagros A. Golis of PRC - Cagayan de Oro requesting for a resolution postponing the conduct of Veterinarians Licensure Examinations in Cagayan de Oro due to lockdown, close borders, travel restrictions, and human mobility restrictions;

**WHEREAS,** the Professional Regulatory Board of Veterinary Medicine and Licensure Office recommend to the Commission the cancellation of the August 2021 VLE in PRC - Cagayan de Oro;

WHEREFORE, premises considered, the Commission RESOLVES to CANCEL the August 4, 5, & 6, 2021 Veterinarians Licensure Examination in PRC - Cagayan De Oro; and

**RESOLVED FURTHER**, that the affected examinees in PRC - Cagayan de Oro may take the next succeeding examination without forfeiture of their examination fees.
