RESOLUTION NO. 1621 Series of 2023

ADDITIONAL EXAMINATION SCHEDULE FOR THE CONDUCT OF THE RADIOLOGIC TECHNOLOGISTS AND X-RAY TECHNOLOGISTS LICENSURE EXAMINATIONS ON JUNE 6 AND 7, 2023

WHEREAS, Section 7 (d) of Republic Act No. 8981 or the "PRC Modernization Act of 2000" empowers the Professional Regulation Commission (Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate, and to determine and fix the places and dates of examinations;

WHEREAS, the Commission issued Resolution No. 1589 (s. 2022) scheduling the Radiologic Technologists Licensure Examination (RTLE) and X-Ray Technologists Licensure Examination (XTLE) on December 11 and 12, 2023 in various testing centers;

WHEREAS, the Philippine Association of Radiologic Technologists, Inc. (PART), Philippine Society of Government Radiologic Technologists, Inc. (PSGRT), and Philippine Association of Deans and Faculty of Colleges of Radiologic Technology, Inc. (PADFOCORTI) requested for an additional schedule of the RTLE and XTLE in 2023 for reasons/justifications cited in their letter to the Commission;

WHEREAS, the Professional Regulatory Board of Radiologic Technology (Board) finds the following reasons/justifications for the request acceptable: (1) it will allow graduates and retakers to take the RTLE and XTLE at the soonest time possible; (2) the addition of more licensed and registered radiologic technologists and x-ray technologists will help resolve manpower shortage and cope with the increasing demand for their professional services; and (3) it will address the need to fill up vacancies for radiologic technologists and x-ray technologists in various healthcare facilities;

WHEREAS, the Board and the Licensure Office recommend to the Commission an additional examination schedule for the conduct of RTLE and XTLE this year;

WHEREFORE, in view of the foregoing, the Commission RESOLVES, as it hereby RESOLVED, to have an additional examination schedule for the conduct of the RADIOLOGIC TECHNOLOGISTS AND X-RAY TECHNOLOGISTS LICENSURE EXAMINATIONS for year 2023, to wit:
