decent pants or slacks

 - c. One (1) piece metered-stamped window mailing envelope
 - d. Two (2) or more pencils (No. 2)
 - e. Ball pens with BLACK ink only
 - f. One (1) piece long brown envelope
 - g. One (1) piece transparent plastic envelope (for keeping your valuables and other allowed items.
 - i. **NON-PROGRAMMABLE CALCULATORS (REFER TO LIST IN THE EXAMINEES GUIDE)**

 - c. CELLULAR PHONES, beepers, portable computers or similar gadget/devices.
