Male Examinees - White polo shirt with collar (without any seal, logo or mark)

Female Examinees - White blouse or shirt with collar (without any seal, logo or mark)  
Decent skirt or slacks
4. **Bring the following on examination day:**
  - a. Notice of Admission
  - b. Applicant's Stub
  - c. Official Receipt
  - d. One (1) piece metered stamp window mailing envelope
  - e. Two (2) or more pencils (**No. 2**)

- f. Ball pens with **BLACK ink only**
- g. One (1) piece long brown envelope
- h. One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items)
